Conference attendance

Only forms that have been completed in their entirety and duly signed can be processed. Confirmation and ticket for the Frankfurt Book Fair can be issued only after receipt of the total amount due.

The last date for advance registration is 20 September 2010. Of course you can register at the Registration Counter at the fair, but an additional service fee of 20.00 EUR will be charged for this service.

The regular conference fee includes admission to the Frankfurt Book Fair and to any lectures and events held on the days booked, as well as the conference documents (not for reduced participation). All the conference documents will be handed out on the spot.

There will be no refund for any surplus admission tickets purchased.

Social programme

There is a limited capacity for the social programme and a minimum attendance is necessary. The organiser reserves the right to cancel the booked programme, in case of not reaching the minimum number of participants. A refund will be granted in this case.

Cancellations

Any changes required or cancellations of registration must be submitted in writing to Messe Frankfurt Venue GmbH & Co. KG. A 50% refund of the conference fee will be granted for cancellations received by 20 September 2010. There will be no refund for any cancellations submitted after 20 September 2010.
